JOB DUTIES

ROLES AND RESPONSIBILITIES

Responsibilities include but not limited to assisting in caring for the children. Classroom responsibilities include assisting with completion of children’s daily homework, snack time and implementation of enrichment activities. Implementation of behavior policies, chaperoning outdoor activities, organizing classroom supplies and communication with the Program Director. Monday-Friday, Hours: 2:30PM-6:00PM unless otherwise adjusted by the Program Director.

The day-to-day responsibilities of the Assistant Group Leader include, but are not limited to:

- Meet all NJ child care program licensing requirements
- Delivery of the After School program goals
- Reporting daily attendance and food program forms
- Manage daily classroom logistics and ensure students comply with social distance rules
- Comply with program cleaning and Covid-related protocols
- Support Group Leader in coordination of enrichment activities
- Attend meetings and trainings
- Supervising students
- Assist Group Leader in creation and implementation of lesson plans
- Others duties as assigned
